

A Message from Our President

At United Services, our vision is Creating Healthy Communities. In some ways, this is short and simple to express. But in between those three words is an inexpressible amount of hard work from our staff and more than 58 years' worth of community partnerships, which we call on every day to get our clients the care that they need.

Sometimes, the care that they need doesn't exist ... yet. As the community behavioral health center, we fill those gaps however we can, and as often as we can, we build the bridge across.

I am incredibly proud of how many bridges we have been able to build, or start building, this last year.

In the wake of COVID, we saw incredible increases in the number of people needing mental health support, especially those experiencing a mental health crisis. As our service system was flooded with this sudden surge in need, the gap between when an individual experienced a crisis and when they were able to engage in outpatient treatment widened.

In 2021 we applied for and were awarded a federal grant to launch a program we called CREST: Crisis Response Engagement and Stabilization Team. Nothing like it previously existed in our area, but we knew it was needed. The program launched in January 2022 and has been very well received by our clients, staff and partners. (More details on CREST inside.)

With the increase in individuals in crisis came a corresponding increase in police interventions. Earlier this year we were able to participate in an expanded pilot program called CRISIS. Thanks to advocacy from our state legislators, funding was allocated for a partnership between United Services and CT State Police Troop D. We expanded this program to other police partners to cover more of our service area. Partnering organizations to date include: Troop D, Coventry Police, Plainfield Police and Putnam Police.

Integrating primary and behavioral health care is best practice for health outcomes and has long been a goal of ours. The barrier has always been funding, and we were grateful earlier this year for the opportunity to apply for a Congressionally Directed Spending Project. With the support of Senators Richard Blumenthal and Chris Murphy, we were allocated funding to start an Integrated Primary Care program at our outpatient clinics in Dayville and Mansfield. This program will launch in January 2023.

Continuing on the path of best practice, we applied for the competitive Certified Community Behavioral Health Clinic – Planning, Development and Implementation Grant from the Substance Abuse and Mental Health Services Administration earlier this year and were the only clinic in Connecticut to be awarded funding in September.

The Certified Community Behavioral Health Clinic (CCBHC) model is for clinics to be an access point for timely, comprehensive and coordinated care for everyone in the community.

CCBHCs are required to provide a comprehensive array of behavioral health services, and meet stringent federal standards for these services, so that people who need care are not caught trying to piece together the behavioral health support they need across multiple providers. In addition, CCBHCs must provide care coordination to help people navigate behavioral health care, physical health care, social services, and the other systems they are involved in.

United Services will receive \$1 million per year for four years through the grant program. We are thrilled to bring these resources to our region and to begin this transformation process to provide more comprehensive and coordinated care which will benefit all of our clients and communities.

It's an exciting time at United Services, and we are grateful to you for joining us on this journey.

Year in Review

September 2021: United Services was awarded a \$3 million Community Mental Health Center (CMHC) grant from the federal Substance Abuse and Mental Health Services Administration for two years of start up costs to launch our Crisis Response, Engagement and Stabilization Team (CREST). Services began in January 2022.

CREST

CREST provides mobile crisis intervention services for up to six months following a mental health crisis.

The team includes clinicians, peer recovery specialists, case managers, and psychiatric APRNs. In the first 9 months, the program served 223 people.




